JET-A-MARINA CLASSIC RULES

1. Your boat and motor must conform to BIA, NMMA, U.S. Coast Guard, or manufacturer horsepower ratings.
2. All boats must be equipped with Coast Guard approved kill switch.
3. Winners will be determined by Tournament Officials based on boat weight.
4. Choose your own partner or fish alone.
5. No more than two contestants per boat. NO EXCEPTIONS!
6. Fishing with artificial baits only is authorized. There will be NO trolling. All fish must be caught in a conventional sporting manner.
7. Only largemouth, smallmouth, and spotted bass, caught between legal tournament hours, will be weighed in.
8. Only largemouth and smallmouth measuring 15 inches or more with the mouth closed will be weighed, spotted bass must measure 12 inches. NO EXCEPTIONS! Violation of any state law is grounds for disqualification.
9. Five fish limit per boat. Culling must be done when 6th fish is caught.
10. BFL measuring board will be the Official Board used.
11. Contestants must check in at Kentucky Dam Village State Park Boat Ramp between 3:00 am and 5:30 am on the day of the tournament.
12. First flight (boat #1 through #60) must check in at Kentucky Dam Village State Park Paddle Boats area.
13. Area inside break wall at Kentucky Dam Marina and the paddle boat area are OFF LIMITS.
14. No bonus points will be given. However, there will be an 8 oz. penalty for each dead fish.
15. Live wells will be checked by the tournament committee prior to the start of the tournament.
16. Late penalty 1lb. per minute - 15 min. late lose all credit for days catch.
17. No alcoholic beverages allowed.
18. Contestants must fish Lake Barkley or Kentucky Lake. Lock through is prohibited.
19. Coast Guard approved PFD must be worn when combustion engine is running above idle speed.
20. Decisions of Tournament Directors are final.
